



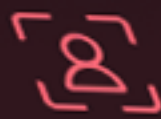

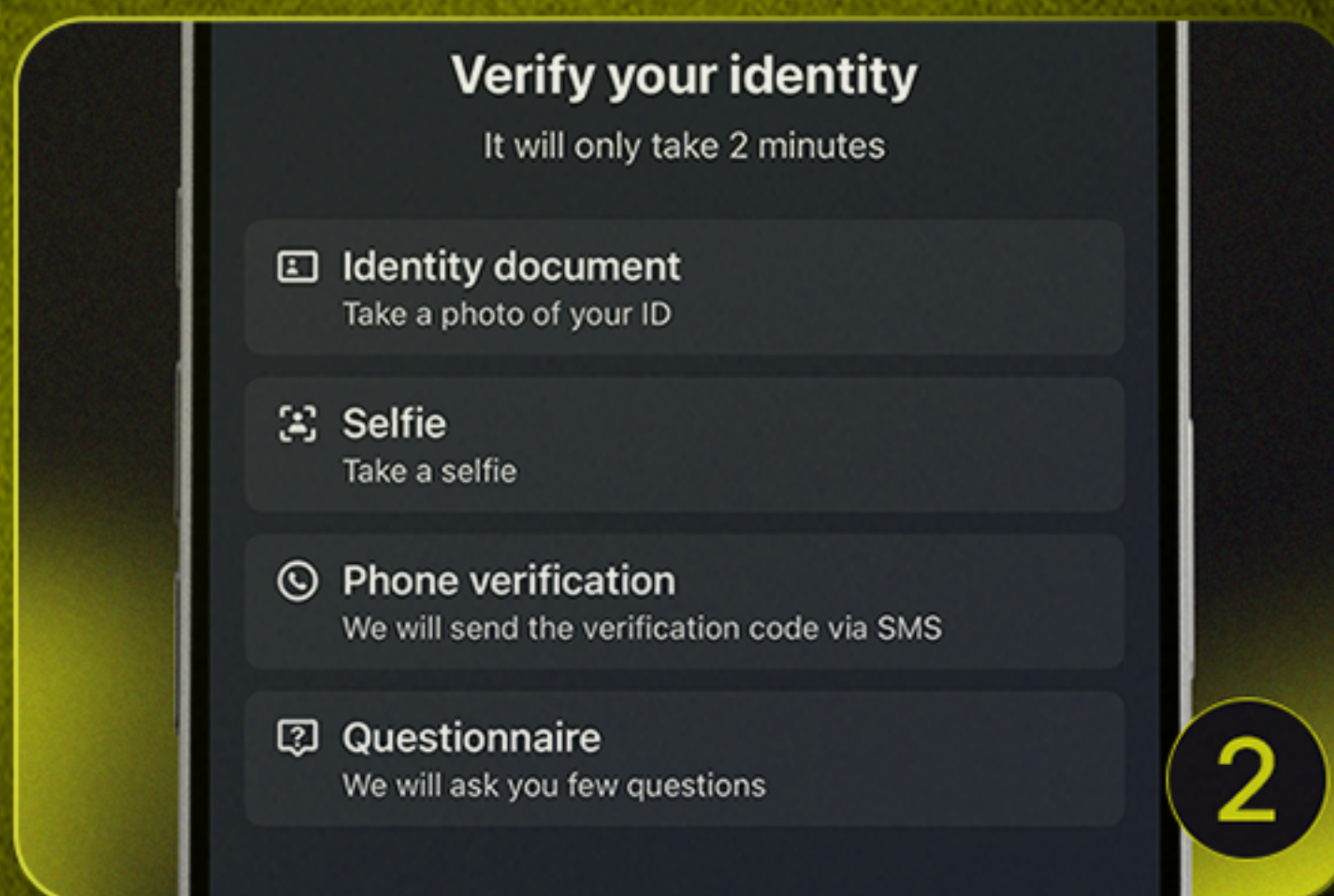


When you first access the platform, you will be shown a message that you have limited access. You need to go through the **KYC verification process** to unlock full access to the platform.

The first step is to select the country you are coming from. In this case, you need to select "**All countries except USA**".

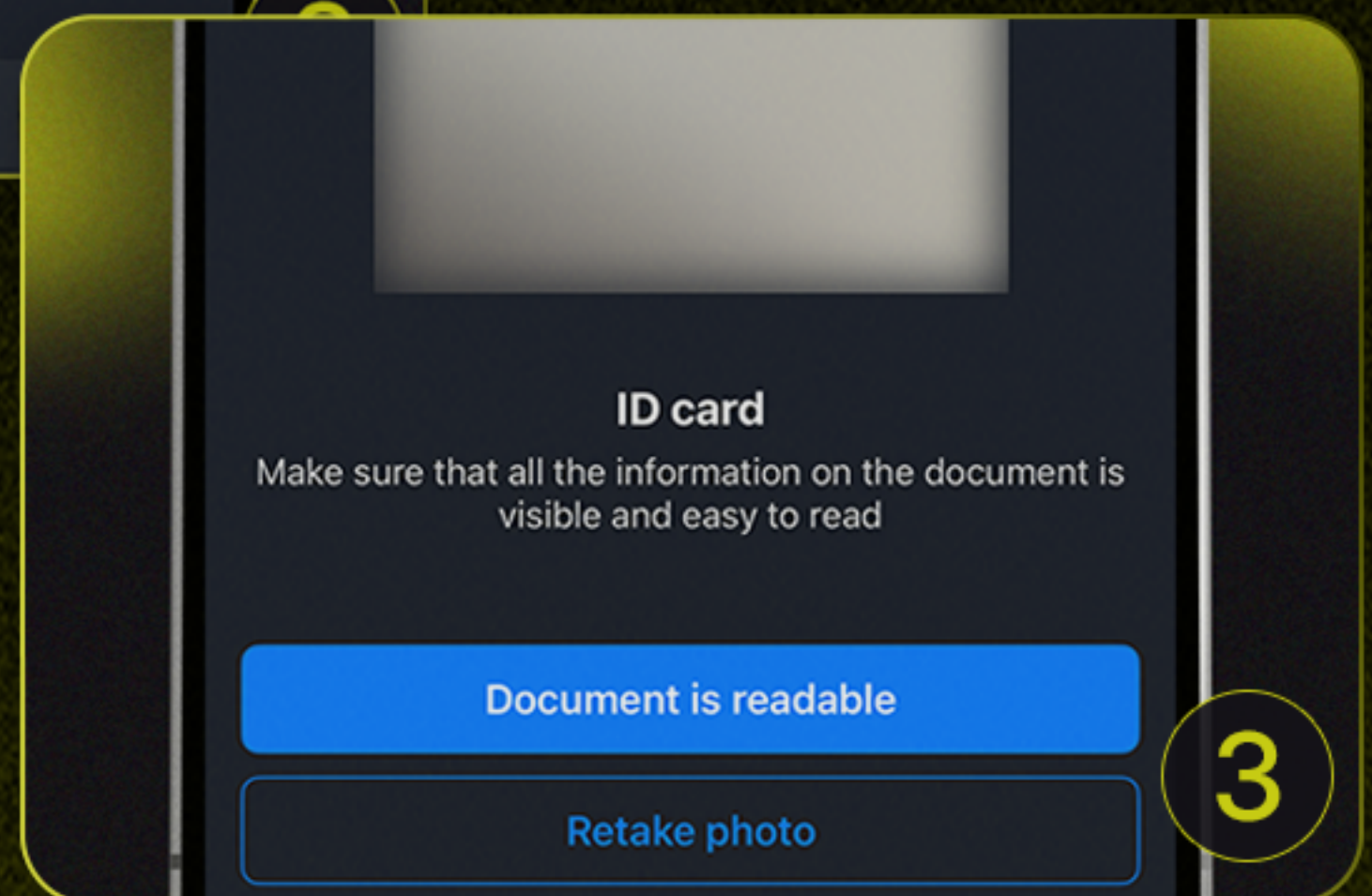
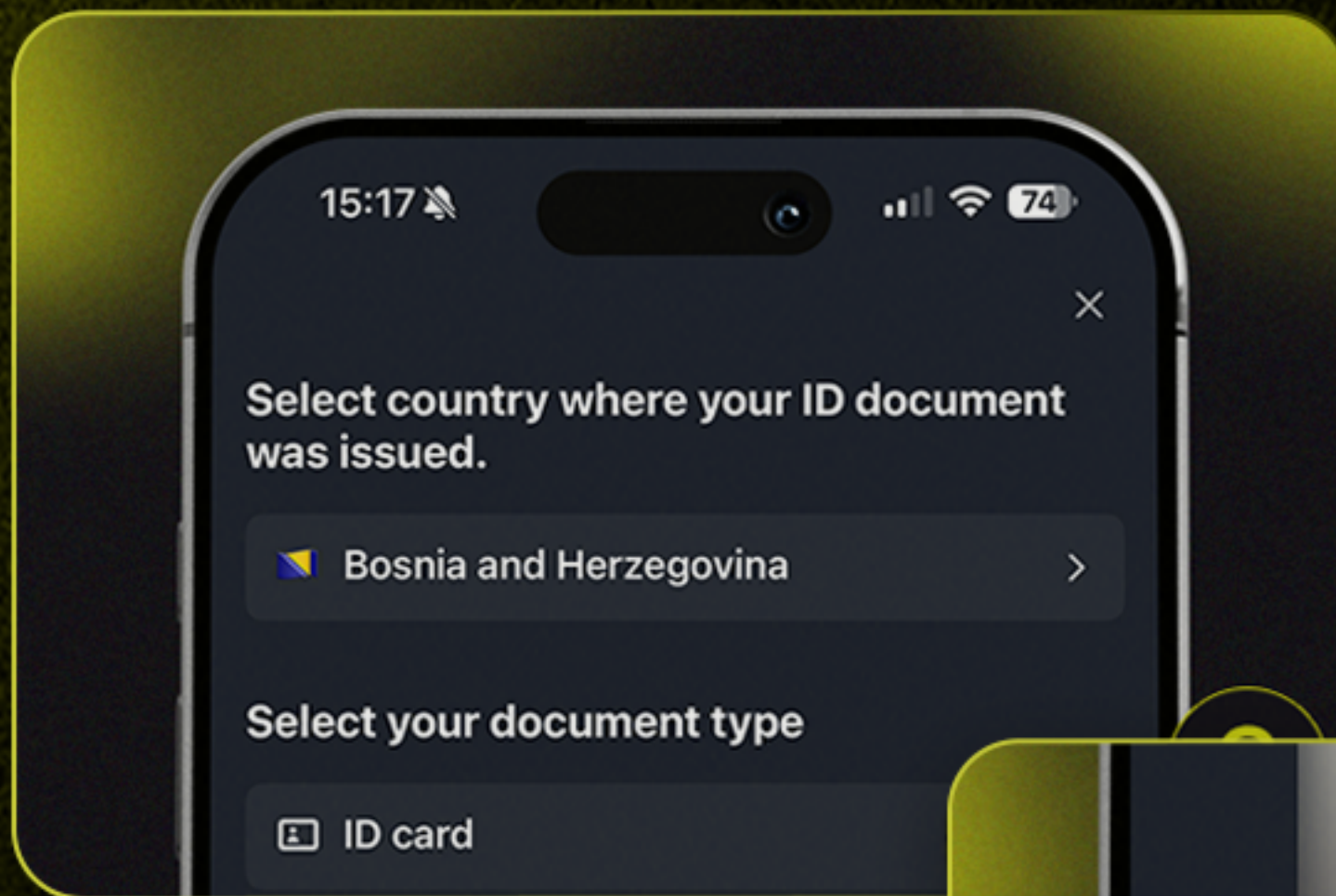

Make sure all the information is on the document visible and clear to read.

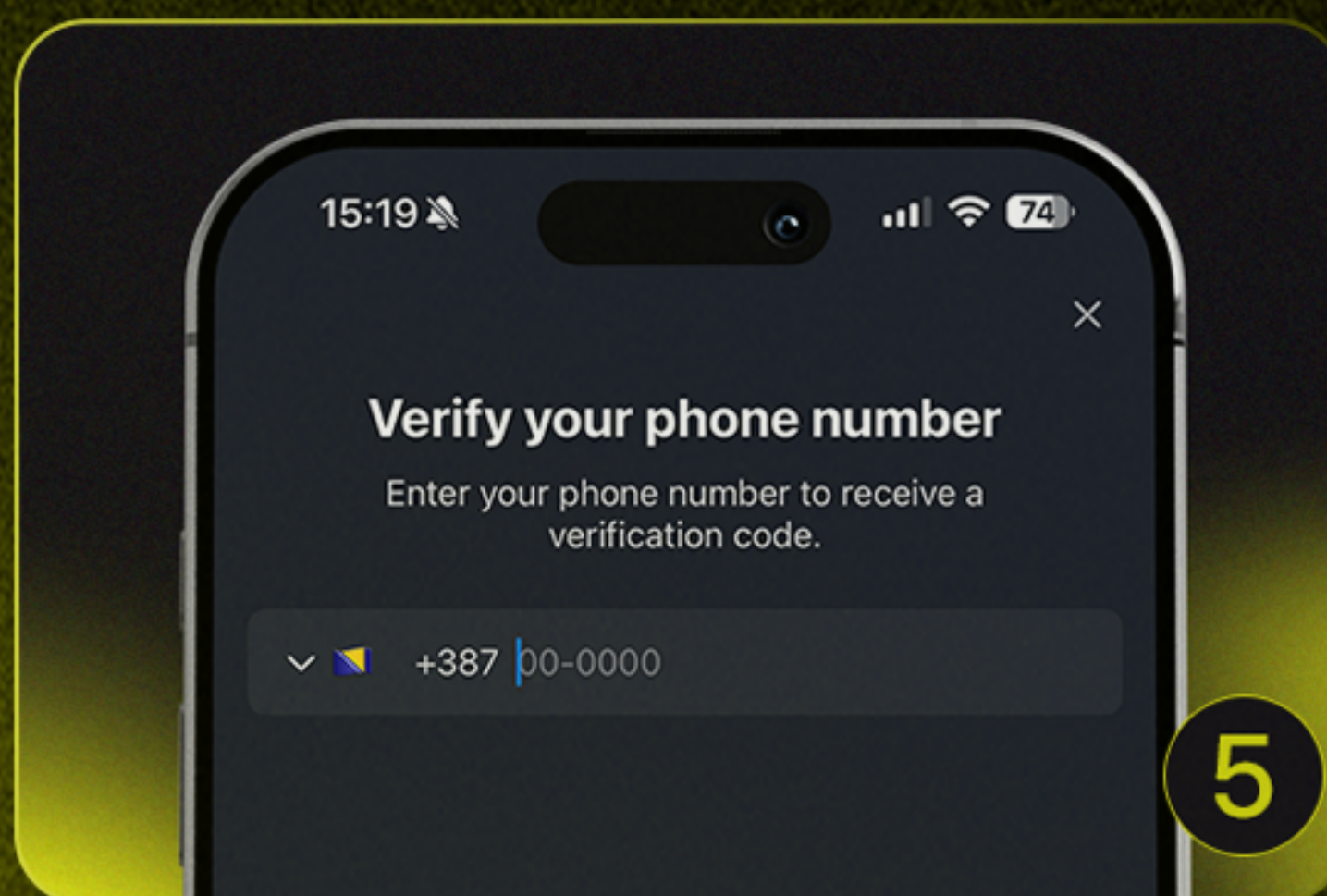


After you have photographed the documents, you need to do **facial scanning** like the one for "Face ID".
